- **Owings District Court Discussion:** Joshua Marks noted that the late George Owings, former Maryland Secretary of Veterans Affairs, was a strong statewide advocate for Veterans Treatment Courts. In recognition of Secretary Owings' contributions, Mr. Marks requested that the Commission consider providing a letter of support to assist in

gaining state-level backing for legislation to name a Judicial District 4 District Court venue in his honor. Mr. Marks was present virtually and available for additional comment. r. Marks noted that the late George Owings, former Maryland Secretary of Veterans Affairs, was a strong statewide advocate for Veterans Treatment Courts. In recognition of Secretary Owings' contributions, Mr. Marks requested that the Commission consider providing a letter of support to assist in gaining state-level backing for legislation to name a Judicial District 4 District Court venue in his honor. VI. Information Sharing / Member Updates

- **Purple Heart Highway Sign:** An update was provided on the Purple Heart Highway signage. Staff reported continued coordination with the State Highway Administration and noted that additional examples of Purple Heart signage from other states had been shared for reference. An update from the State is expected within the next week. Challenges remain regarding the proposed placement along Route 4, as the State has expressed concerns about removing an existing "Welcome to Calvert County" sign. Further clarification and review of signage requirements are ongoing.
- **Outreach:** An outreach visit is scheduled for January 30th, 2026, at Huntingtown High School during a teacher workday to meet with school staff and provide an overview of the Commission's role and available community support. Coordination with Calvert High School is also being explored. A JROTC instructor at Huntingtown High School was identified as a potential candidate for Commission membership due to strong community involvement.
- **Military Families Event:** Planning is underway for a Military Families event scheduled for April 18, to be held from 2:00 p.m. to 6:00 p.m. at the American Legion location. Additional details will be provided as planning continues.
- **Office On Aging:** Information was shared regarding available resources through the Office on Aging. Veterans aged 50 and older who may need assistance, including nutrition services, caregiver support, or housing resources, are encouraged to reach out for potential support.
- **Veterans Treatment Court:** It was noted that there is currently no funding available for a Veterans Treatment Court. The matter will continue to be monitored and explored for future opportunities.
- **Farmers Market:** The Commission discussed plans to begin participating at the North Beach Farmers Market on select Saturday mornings to promote the Commission and increase community awareness.
- **Serving Together:** An update was provided for Serving Together, noting a return to twice-monthly in-person availability on the second Wednesday and fourth Friday from 9:00 a.m. to 4:00 p.m. at the Southern Pines Senior Center. Additionally, information was shared about the Caregiver Connect Program, a monthly virtual support group for caregivers, including those who are military members themselves or who care for individuals in military families.
