## **Joint Public Hearing Scheduled for Calvert County Zoning Ordinances**

**PRINCE FREDERICK, Md. – Nov. 21, 2018** – The Calvert County Board of County Commissioners (BOCC) will hold a joint public hearing with the Calvert County Planning Commission Tuesday, Nov. 27, 2018, to consider and receive comments on proposed text amendments to the Calvert County zoning ordinance and to the zoning ordinances for the Dunkirk, Huntingtown, Lusby, Owings, Prince Frederick, St. Leonard and Solomons town centers.

The public hearing will cover proposed amendments on restructuring the Town Center architectural review process, revising the adequate public facilities regulation for schools, and a proposal to revise the critical area fee-in-lieu of buffer mitigation in the county's environmental requirements to be consistent with the fee set by the Critical Area Commission.

The hearing will begin at 7 p.m. at the Harriet E. Brown Community Center located at 901 Dares Beach Road in Prince Frederick. Citizens are encouraged to view the ordinances [online](#).
