### Public Hearing Scheduled for Calvert County Fiscal Year 2021 Commissioners' Recommended Budget

**PRINCE FREDERICK, Md. – May 18, 2020** – The Calvert County Board of County Commissioners (BOCC) will hold a public hearing Tuesday, May 19, 2020, at 7 p.m. to consider and receive comments regarding the fiscal year (FY) 2021 commissioners' recommended operating and capital improvement budget.
