### Calvert County to Hold Public Hearing on FY 2022 Staff Recommended Budget

**PRINCE FREDERICK, Md. – March 10, 2021** – The Calvert County Board of County Commissioners (BOCC) will hold a public hearing Tuesday, March 23, 2021 at 7 p.m. to consider and receive comments regarding the fiscal year (FY) 2022 staff recommended operating and capital improvement budget.
