**PRINCE FREDERICK, Md. – Nov. 15, 2022** – The Calvert County Board of County Commissioners will hold a public hearing Tuesday, Nov. 29, 2022, at 6:30 p.m. to receive and consider comments on proposed amendments to the Calvert County Comprehensive Plan, adopted in August 2019. The public hearing will be held at the Harriet E. Brown Community Center located at 901 Dares Beach Road in Prince Frederick. Proposed amendments would reduce or eliminate the future expansions for the Huntingtown, Lusby, Prince Frederick and Solomons town centers.
