## Where can I get information on housing assistance and low-cost rental units in Calvert County?

The **Housing Authority of Calvert County** manages several housing assistance programs for citizens with low or fixed income:

- ◆ Housing Choice Voucher (Section 8)
- ◆ Rental Assistance (RAP) Program
- ◆ Public Family Housing
- ◆ Senior Apartments

*\*Application, income limits and eligibility required.\**

The Housing Authority also maintains a voluntary registry of private rental units.
