

**PERTAINING TO APPROVAL OF A BUDGET ADJUSTMENT TO ALLOCATE THE USE OF 3<sup>rd</sup> DISTRICT ROAD EXCISE TAX FOR CHANEYVILLE ROAD BRIDGE REPAIRS.**

**WHEREAS**, the Board of County Commissioners of Calvert County, Maryland, has the authority, pursuant to 5-103 of the Code of Public Local Laws of Calvert County, Maryland, to enact certain budgetary adjustments by resolution; and

**WHEREAS**, the Board of County Commissioners of Calvert County, Maryland, has been advised by the Department of Finance and Budget that these additional funds are needed for repairs needed at the Chaneyville Road Bridge; and

**WHEREAS**, the Board of County Commissioners of Calvert County, Maryland, has been advised that the needed repairs are necessary to address an emergency for the protection of life and property; and

**WHEREAS**, the Board of County Commissioner of Calvert County, Maryland, desires to increase the appropriations of the project to ensure there are sufficient funds for the bridge repairs costs with the source being allocated from 3<sup>rd</sup> District Road Excise Tax Revenue (20%) and monies received from the Federal Aid Participation Program administered by the State Highway Administration; and


**WHEREAS**, a public hearing regarding this budget adjustment was held on August 16, 2011, at which time the Board of County Commissioners of Calvert County, Maryland, received public comment; and

**WHEREAS**, proper notice of this hearing was published in two County newspapers for two consecutive weeks before the public hearing.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of County Commissioners of Calvert County, Maryland, hereby approves Budget Adjustment #84 in the amount of \$144,692, a copy of which is attached hereto and made a part hereof, to increase the budget for the Chaneyville Road Bridge with the source of funds being allocated from 3<sup>rd</sup> District Road Excise Tax Revenue (\$28,938) and Federal Aid Participation Program (\$115,754).




