RESOLUTION PERTAINING TO APPROVAL OF BUDGET ADJUSTMENT #BA077CIP

WHEREAS, Title 5 of the <u>Code of Public Local Laws of Calvert County</u>, <u>Maryland</u>, being Title 5 of *Article 5* of the <u>Code of Public Laws of Maryland</u> (hereinafter, the "<u>Code</u>"), authorizes and empowers the Board of County Commissioners of Calvert County, Maryland (hereinafter, the "Board of County Commissioners") to adopt the Annual Budget and Appropriation Act each year;

WHEREAS, the Board of County Commissioners has the authority pursuant to Section 5-103 of the <u>Code</u> to enact certain budgetary adjustments by Resolution;

WHEREAS, the Board of County Commissioners has been advised by the Department of Public Works there is a need to transfer funds totaling Four Hundred Eighty-Nine Thousand One Hundred Forty-Four and 61/100 Dollars (\$489,144.61) from multiple completed Transportation Projects: Barstow Leitches Wharf, Lake Karlybrook Dam, Hardesty at Dalrymple Rd, Shores of Calvert Dam replacement and the Lake Ridge Dam Repairs to the Capital Project Road Drainage (piping);

WHEREAS, the Board of County Commissioners has been advised by the Department of Finance and Budget that funds totaling Four Hundred Eighty-Nine Thousand One Hundred Forty-Four and 61/100 Dollars (\$489,144.61) from revenues generated from Excise Tax are available in the following Capital Projects: Barstow Leitches Wharf, Lake Karlybrook Dam, Hardesty at Dalrymple Rd, Shores of Calvert Dam replacement, and the Lake Ridge Dam Repairs;

WHEREAS, the Board of County Commissioners desires to reallocate the appropriations of the capital budget to ensure there are funds available to complete the required repairs/replacement of the countywide drainage systems for the aforementioned project;

WHEREAS, a public hearing regarding this Budget Adjustment #BA077CIP was duly advertised in two County newspapers for two consecutive weeks before the public hearing as required by Section 5-103(c) of the <u>Code</u> and held on May 18, 2021 at which time the Board of County Commissioners received public comment;

WHEREAS, upon due consideration of the comments of the public and staff and in furtherance of the public health, safety and welfare, the Board of County Commissioners finds that it is in the best interest of the public health, safety and welfare of the citizens of Calvert County, Maryland to adopt Budget Adjustment #BA077CIP as set forth in Exhibit "A", attached hereto and made a part hereof.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Calvert County, Maryland, hereby approves and enacts the appropriations and expenditures set forth in Budget Adjustment #BA077CIP, in the total amount of Four Hundred Eighty-Nine Thousand One Hundred Forty-Four and 61/100 Dollars (\$489,144.61) as reflected in Exhibit A, incorporated herein by reference and made a part hereof;

BE IT FURTHER RESOLVED AND ORDAINED, by the Board of County Commissioners of Calvert County, Maryland that the Calvert County Capital Improvement Program for FY2021, as amended hereby, shall remain in full force and effect;

BE IT FURTHER RESOLVED AND ORDAINED, by the Board of County Commissioners of Calvert County, Maryland, that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, by a court of competent jurisdiction, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of the Resolution shall be enforceable and valid, unless deletion of the invalid
