Tricia Powell	Term limits-not 12 years
Theresa Kuhns	7.A2.A-No degree-field experience; B-other types Mid. Alt. Womens; include disabled under 65; include women
Kate-Socialists of MD	No requirement being law enforcement; no requirement for higher education or clergy; don't exclude prior crimes; PAB more defined subpoena and legal powers; defined conflict of interest limits; demographics not inclusive of everyone as doesn't list indigenous people
Ed Bailor	how would board effect Federal agencies; penalty for breach of confidential information
Claire Hill	No background checks unless required across the board; advisory group to amend
Tom Phelps	Pro background checks like deputies, removal for some if commit crime while on board
Katina Mackall	No background check, Calvert is 10% black but account for 30% of arrests, citizen complaint oversight panel, secretly held meeting; police can't police themselves; diverse
M. Johnson	background checks yes, impartial
Kip Atlee	PAB training like ACC, if doesn't require law enforcement experience, don't require it; experience outside County should be included; aid in filing complaints; don't limit ACC to misconduct where supervision was lacking or training; precedence of criminal process before administrative review, don't want process to take years; Section 6A-no law enforcement
Duwane Rager-Dem. Central Committee	Equitable review; doesn't meet intent of being Community Oversight; direct experience; no background checks; loosen requirement for law enforcement experience; transparency
Bill Goodwin	Who has oversight of these committees; MOU with Sheriff to abide by results; ACC doesn't state diversity
Michael Kent-NAACP	Can be juror, can be on PAB, treatment at traffic stops/intended traffic stops; roadside and body cavity searches; mentally handicap treatment
James Teal	No requirement or priority for law enforcement; no family in law enforcement; no prior conviction exclusion; budget must be significant for work to be done-more than \$500; distribute complaint forms with encounters; how subpoena powers will be practiced; represent community not government; transparency; disclose how/why members selected or not selected
Lisa Mackall	Followed because driving specific type of vehicle; 2-3 years for Board members; no prior law enforcement, education; all generations represented; voting for nominated members; ethical conduct and training
Malcom Funn	Citizens committee-not so top heavy; chair of PAB need not be chair of ACC; follow law with respect to intent of board
Mary's ipad	too police heavy, not citizen's board; if law enforcement, must have 3-5 year break; transparency
Summer from Owings	There have been deaths in police custody; mindful of weight of the board
Bucky Wells	Don't need PAB in Calvert County; don't staff with amateurs; people who don't cooperate
Susan Rowark-Comm Mediation Center	MOU with Sheriff to mediate citizen complaints; some complaints can go to mediation
Katina Mackall	Responding to incidents/harassing women; police can not police themselves
Len Zuza	Can't judge your own; no former police or military
Nick DeFelice-FOP	policing is the public's business; emphasizing ethics; more training
Naquita Coates	People afraid to come to Calvert; more police in Calvert County; don't feel safe here

Toby Mackall	Attitude and arrogance of police; Internal Affairs is part of brotherhood; separation; need accountability
