The Calvert County Ethics Code requires Lobbyists to annually register with the Ethics “Commission on or before the beginning of each calendar year in which a person expects to lobby or within five (5) days after engaging in Lobbying activities.”

Note: Lobbyists registered with Calvert County must file a semi-annual “Lobbying Activity Report (Form 4)” by January 31 and July 31.
