

**A RESOLUTION PERTAINING TO APPROVAL OF BUDGET ADJUSTMENT BA-44**

**WHEREAS**, Title 5 of the Code of Public Local Laws of Calvert County, Maryland, being Title 5 of *Article 5* of the Code of Public Laws of Maryland (hereinafter, the “Code”), authorizes and empowers the Board of County Commissioners of Calvert County, Maryland (hereinafter, the “Board of County Commissioners”) to adopt the Annual Budget and Appropriation Act each year;

**WHEREAS**, the Board of County Commissioners has the authority pursuant to Section 5-103 of the Code to enact certain budgetary adjustments by Resolution;

**WHEREAS**, the Board of County Commissioners has determined that there is a need to make additional funding available to various Calvert County Departments to increase the current budget to address the current needs of the Calvert County government and its citizens;

**WHEREAS**, the Board of County Commissioners desires to make improvements to Chesapeake Hills Golf Course, (the “Park”) amenities and maintain the Park for public use of recreational resources and safety of citizens;

**WHEREAS**, Parks and Recreation staff have recommended and the Board of County Commissioners desires to amend the adopted Budget for FY 2023 to appropriate and allocate One Hundred Forty-One Thousand Fifty-Six Dollars (\$141,056) for the purchase of golf carts at Chesapeake Hills Golf Course through a loan from the General Fund of One Hundred Twenty-Nine Thousand One Hundred Fifty Dollars (\$129,150) and by moving Eleven Thousand Nine Hundred Six Dollars (\$11,906) from cost center GC – Golf Course Administration/Spend Category Equipment Leasing, to fund One Hundred Forty One Thousand Fifty Six Dollars (\$141,056) to cost center GC – Golf Course Maintenance/Spend Category Equipment – Off Road.

**WHEREAS**, upon due consideration and in furtherance of the public health, safety and welfare, the Board of County Commissioners finds that it is in the best interest of the public health, safety and welfare of the citizens of Calvert County, Maryland to adopt budget Adjustment BA-000044 as set forth in Exhibit A, attached hereto and made a part hereof.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of County Commissioners hereby approves and enacts the appropriations and expenditures set forth in Budget Adjustment BA-000044, in the amount of One Hundred Forty-One Thousand Fifty-Six Dollars (\$141,056), a copy of which is attached hereto as Exhibit A and made a part hereof, to amend and append financial resources to the FY 2023 operating budget as set forth in Exhibit A, attached hereto and made a part hereof;

**BE IT FURTHER RESOLVED AND ORDAINED**, by the Board of County Commissioners of Calvert County, Maryland that the Calvert County Adopted Budget for FY 2023, as amended hereby, shall remain in full force and effect;

**BE IT FURTHER RESOLVED**, by the Board of County Commissioners that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion of the provision, and that the remainder of the Resolution shall be enforceable and valid;

**BE IT FURTHER RESOLVED**, by the Board of County Commissioners that the foregoing recitals are adopted as if fully rewritten herein; and

**BE IT FURTHER RESOLVED**, by the Board of County Commissioners that this Resolution shall be effective upon recordation and publication of a fair summary.
