

A RESOLUTION PERTAINING TO AN AUTHORIZATION TO ENTER A MULTI-YEAR CONTRACT

WHEREAS, Title 6 of the Code of Public Local Laws of Calvert County, Maryland, being Title 6 of Article 5 of the Code of Public Laws of Maryland (hereinafter, the “Code”), authorizes and empowers the Board of County Commissioners of Calvert County, Maryland (hereinafter, the “Board of County Commissioners”) to enter into a contract requiring the payment of funds from appropriation of more than one fiscal year, under certain conditions and approved by Resolution;

WHEREAS, the Board of County Commissioners has the authority pursuant to Section 6-103 (c)(2)(iv) of the Code to award a multi-year contract for “[i]nformation technology, including software and the provision of voice, data, and Internet services”;

WHEREAS, the Board of County Commissioners previously awarded a contract to Zencity on June 15, 2022, for a new digital community survey and engagement platform;

WHEREAS, a further interface to the aforesaid Zencity platform is necessary, said interface being Engage;

WHEREAS, the Engage interface is a separate contract with a two-year term recommended by the Department of Communications & Media Relations.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Calvert County, Maryland, hereby approves the award of a contract for the Engage interface for a period not to exceed 20 years, including the initial contract term and all options;

BE IT FURTHER RESOLVED by the Board of County Commissioners of Calvert County, Maryland that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of the Resolution shall be enforceable and valid;

BE IT FURTHER RESOLVED, by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein; and

BE IT FURTHER RESOLVED, by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective upon recordation without publication of a fair summary.
