

**A RESOLUTION FOR THE PURPOSE OF APPENDING CLUBHOUSE AND  
ADVERTISING FEES TO THE CALVERT COUNTY PARKS AND RECREATION FEE  
SCHEDULES**

**WHEREAS**, as prescribed at Section 82-1-103(B)(5) of the Calvert County Code the Board of County Commissioners of Calvert County, Maryland, (the "Board") has authority to set fees for use and services provided at all properties designated or acquired by the County for parks, parkways, playgrounds, recreational centers, conservation, and for other recreational purposes;

**WHEREAS**, it is important for the funding of successful County Parks and Recreation Department facilities, operations and program that some funds or revenues, in addition to property taxes, be generated to assist in financing the cost of these Parks and Recreation facilities, operation, and programs;

**WHEREAS**, the Board adopted fee schedules for Parks and Recreation facilities, fees, reservation and programs for calendar year 2023, as recommended by the Department of Parks & Recreation by Resolution 50-22;

**WHEREAS**, the anticipated opening of the Chesapeake Hills Golf Clubhouse warrants adoption of fees for rental packages for calendar year 2023 that follow those adopted by Resolution approved by the Board on July 11, 2023 for calendar year 2024, and adopt advertising fees; and

**WHEREAS**, it is the Board's intent by the adoption of this Resolution that if any prior established fee is in conflict with the fee schedule attached hereto as Exhibit A and made a part hereof, those attached hereto shall prevail.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Calvert County, Maryland that the "Clubhouse Rental Package" and "Annual Approved Vendor Advertising Fees" attached hereto as Exhibit A, incorporated herein by reference and made a part hereof, is hereby adopted as recommended by the Department;

**BE IT FURTHER RESOLVED** by the Board of County Commissioners of Calvert County, Maryland that any conflicting prior fee is hereby superseded, repealed and replaced with the fees adopted pursuant to this Resolution;

**BE IT FURTHER RESOLVED** by the Board of County Commissioners of Calvert County, Maryland that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion of the provision, and that the remainder of the Resolution shall be enforceable and valid;

**BE IT FURTHER RESOLVED** by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein; and

**BE IT FURTHER RESOLVED** by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective following recordation without publication of a fair summary.
