

**A RESOLUTION PERTAINING TO  
APPROVAL OF BUDGET AMENDMENT #BA2025-000310**

**WHEREAS**, Title 5 of the Code of Public Local Laws of Calvert County, Maryland, being Title 5 of Article 5 of the Code of Public Laws of Maryland (hereinafter, the “Code”), authorizes and empowers the Board of County Commissioners of Calvert County, Maryland (hereinafter, the “Board of County Commissioners”) to adopt the Annual Budget and Appropriation Act each year;

**WHEREAS**, the Board of County Commissioners has the authority, pursuant to Section 5-103 of the Code to enact certain budgetary amendments by Resolution;

**WHEREAS**, the Department of Economic Development received notice that their Rural Maryland Economic Development grant award through Tri-County Council for Southern Maryland has been modified to include new funds from a state reallocation;

**WHEREAS**, the Open Air Multi-Use Pavilion Permitting and Construction Project at the Armory Building Site in Prince Frederick Town Center project has been allocated an additional Four Hundred Fifty-Four Thousand Two Hundred Seventy and 67/100 Dollars (\$454,270.67) for Ice Rink and Commercial Kitchen Additions;

**WHEREAS**, the Board of County Commissioners desires to allocate the additional grant funding in the amount of Four Hundred Fifty-Four Thousand Two Hundred Seventy and 67/100 Dollars (\$454,270.67) to capital project CIP-000012: Armory Site Development;

**WHEREAS**, a public hearing regarding this Budget Amendment #BA2025-000310 was duly advertised in two County newspapers for two consecutive weeks before the public hearing, as required by Section 5-103 of the Code, and held on March 11, 2025, at which time the Board of County Commissioners received public comment; and

**WHEREAS**, upon due consideration of the comments of staff and the public, and in furtherance of the public health, safety and welfare, the Board of County Commissioners finds that the adoption of Budget Amendment #BA2025-000310 as set forth in Exhibit A, attached hereto and made a part hereof, is in the best interest of the public.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of County Commissioners of Calvert County, Maryland, hereby approves and enacts the appropriations and expenditures set forth in Budget Amendment #BA2025-000310, in the total amount of Four Hundred Fifty-Four Thousand Two Hundred Seventy and 67/100 Dollars (\$454,270.67) as reflected in Exhibit A and made a part hereof, to amend and append financial resources to the FY2025 Calvert County Capital Budget Appropriations as set forth therein;

**BE IT FURTHER RESOLVED** by the Board of County Commissioners of Calvert County, Maryland that the Calvert County Adopted Budget for FY 2025, as amended hereby, shall remain in full force and effect;

**BE IT FURTHER RESOLVED** by the Board of County Commissioners of Calvert County, Maryland that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of the Resolution shall be enforceable and valid;

**BE IT FURTHER RESOLVED**, by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein; and


