

**A RESOLUTION PERTAINING TO AN
AUTHORIZATION TO ENTER A MULTI-YEAR CONTRACT**

WHEREAS, Title 6 of the Code of Public Local Laws of Calvert County, Maryland, being Title 6 of *Article 5* of the Code of Public Laws of Maryland (hereinafter, the “Code”), authorizes and empowers the Board of County Commissioners of Calvert County, Maryland (hereinafter, the “Board of County Commissioners”) to enter into a contract requiring the payment of funds from appropriation of more than one fiscal year, under certain conditions and approved by Resolution;

WHEREAS, the Board of County Commissioners, pursuant to Section 6-103 (a) of the Code may contract to purchase supplies or services for periods of more than one year “when it is advantageous to the county to do so”;

WHEREAS, the Board of County Commissioners has the authority pursuant to Section 6-103 (c)(2)(iv) of the Code to award a multi-year contract for “[i]nformation technology, including software and the provision of voice, data, and Internet services”;

WHEREAS, it is in the best interest of Calvert County to have a mass notification system for its citizens and the Board of County Commissioners has previously utilized Everbridge, Inc. to provide the services and software for said mass notification system;

WHEREAS, it is advantageous for Calvert County to renew its contract with the aforesaid Everbridge, Inc. for said mass notification system for a period of two (2) years; further renewal of software subscriptions are necessary through county government at various times;

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners of Calvert County, Maryland, hereby authorizes a contract requiring the payment of funds from appropriations of more than one year for Everbridge, Inc. to provide the services and software for said mass notification system;

BE IT FURTHER RESOLVED by the Board of County Commissioners for Calvert County, Maryland that, in the event any portion of this Resolution is found to be unconstitutional, illegal, null or void, it is the intent of the Board of County Commissioners to sever only the invalid portion or provision, and that the remainder of the Resolution shall be enforceable and valid;

BE IT FURTHER RESOLVED, by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein; and

BE IT FURTHER RESOLVED, by the Board of County Commissioners of Calvert County, Maryland that this Resolution shall be effective upon recordation without publication of a fair summary.
