

**PERTAINING TO THE WAIVER OF THE TAX APPLICABLE TO NEW CONSTRUCTION FOR THE AUTISM PROJECT, INC., A MARYLAND NON-PROFIT, CHARITABLE CORPORATION**

**WHEREAS**, the Board of County Commissioners recognizes that there is a significant need for decent, safe and sanitary housing in Calvert County for families of low or limited incomes;

**WHEREAS**, The Autism Project, Inc., a Maryland non-profit, charitable corporation, proposes to develop and operate a rental housing development located at 9310 Dayton Ave., North Beach, Maryland for the use and benefit of individuals diagnosed with Autism (the "Project"), which will assist families of low or limited income as required by applicable law or regulations;

**WHEREAS**, The Autism Project, Inc. submitted an application requesting a waiver of the Building Excise Tax imposed by Chapter 136, Article III of the Code of Public Local Laws of Calvert County, Maryland; and

**WHEREAS**, The Autism Project, Inc. is an IRS-approved 501(c)(3) nonprofit organization with a charitable mission and has recorded covenants among the Land Records of Calvert County, Maryland at Liber 4414, folio 90, thereby ensuring the Project's compliance with the requirements of Section 136-15(B) of the Code of Public Local Laws of Calvert County, Maryland.

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of County Commissioners hereby supports The Autism Project and grants a waiver of the full tax applicable to new construction (the Building Excise Tax) in accordance with and as permitted by Section 136-15(B) of the Code of Public Local Laws of Calvert County, Maryland.

**BE IT FURTHER RESOLVED** by the Board of County Commissioners of Calvert County, Maryland that the foregoing recitals are adopted as if fully rewritten herein.


